The MAHANoy AREA Historical met on November 24, 1998 at 7pm in the MAHANoy City Public Library. Of the four executive officers, Vice President Jim Trusky was not in attendance.

President Larry Levy review the by-laws and the body voted on an appropriate definition to describe the Restoration + Revitalization Committee. Members were also chosen for the Remaining Committees.

A committee that was resurrected on a short term basis is the "New Building" committee. This committee will oversee the construction of the train depot. George Krall and Mary Wohnhaas are in charge of this committee.
