- IV. Letter from Cathy Setcavage Mogul looking for photos or videos of the Mahanoy Area Band from 1968. Request will be put out on the Historical Society Facebook page and at the Sensational Sixties Reunion in May.
- V. Letter from United Veterans Parade Committee inquiring as to whether we will participate in the Memorial Day Parade. Frank Senglar will contact Francis Burke about this possibility.

# **UNFINISHED BUSINESS**

- I. Peg Grigalonis is continuing to work on the brochure for Lithuanian Days. The brochure must contain the Explore Schuylkill logo as well as advertisements for bringing people into the county.
