ACCESSIONS – I. A number of old bottles were donated by Larry Levy.

II. A box of ceramic houses was donated by Anne Evans.

UNFINISHED BUSINESS

- I. Donation check for cemetery fence project will be sent.
- II. Discussion was held regarding the John Oakley prints and how best to make them accessible. Terry Rang reported that her existing prints are the best quality we have available at present. Peg Grigalonis brought an original painting to show, which can be scanned to make prints.
- III. The digital files of the Record American newspapers that were sent to newspapers.com are acceptable.
 However, each page would need an individual pdf. Question remains as to whether newspapers.com is able to do this.
- IV. The remainder of the SCVB grant for Lithuanian Days needs to be spent in an appropriate way.

NEW BUSINESS

- I. Peg Grigalonis reported that Glenn Love indicated that the Mahanoy Township Alumni will no longer be having reunions or meetings. He expressed some concerns about the existing MTHS display cases at the high school. He further offered to donate some funds to the historical society to pay for additional storage space, possibly climate controlled.
- II. The following motion was made by Paul Coombe and seconded by Ed Miller: The Mahanoy Area Historical Society would accept the display cases and contents if offered to us by the Mahanoy Township Alumni, with the approval of the Mahanoy Area School District. The motion passed with a vote of 7 to 1.
- III. The existing Lithuanian flag which is in the front window will be replaced with a smaller version.
- IV. Paul Coombe will send digital copies of the Charles Palulis glass slides to Frank Senglar, who will take them to Neal Flexor to have them converted into high resolution pictures and put on a CD.
